Enter lot number(s) of the item(s) you wish to bid for on the bid form, write your bid alongside, then send your bids form to us. Your bid represents the maximum you are prepared to pay (inclusive of VAT, except where lots are suffixed by 'T'). Lots will be sold at the lowest price possible, subject to other bids.

When two or more identical bids are received for the same items, the earliest bid received will be the winner.
